- You must get **DOUBLE** the number electives approved by your advisor than you will actually take, in case of changes in course availability or schedule conflicts. You will not be able to submit this form unless you fill in an equal number of top choices and alternates.

* = You will have the opportunity to purchase Internet access during orientation. Some landlords have equipped their apartments with WiFi, which you can use for a fee of 50 euro per month, split amongst you and your roommates. Since not all landlords have equipped their apartments with WiFi, a second option is to rent a USB key which gives you WiFi on your laptop anywhere you go in Florence. This costs approximately 225 euro per semester, per student. You can read about this service, including costs and limitation, here: www.studentfreemove.com. Please note that the university and ASA do not intervene or assist with Internet set-up, repairs, etc. Once again, you will have the opportunity to purchase these things during orientation.

- Books and materials for classes; lab fees for required academic field trips

STEP 3: HOUSING INFORMATION

As an ASA student, housing is arranged for you by FUA in a shared student apartment. The university does not own or lease apartments, but works as a facilitator to find accommodation for the students. FUA offers **Housing Assistance Services** with the sole intention of making a positive contribution to the students' study abroad experience.

Housing Policies:

- Students will not be able to choose their apartment or change roommates. All roommate requests must be specified below.
- Housing is limited and allocated in order of application receipt.
- If a student's room request cannot be honored due to space limitations, the student will be assigned according to availability.
- Students will not be allowed to check in to their apartments before the check-in date or to check out of their apartments after check-out date.
- All students must pay a \$350 damage deposit to ASA at least one month prior to departure. This will be refunded upon returning home, as long as nothing is missing or damaged in your apartment and you have paid your program fees in full.
- Overnight guests are NOT allowed.

Description of shared student apartments:

- Most apartments have 2 or 3 bedrooms. A very limited number have 1 bedroom. Some have more than 3 bedrooms. Therefore, 4-8 students generally share an apartment. Students are assigned to double or triple bedrooms and in all cases will share the apartment/residence with several other students.
- Apartments are furnished and equipped with bed linens, a fully fitted kitchen, basic pots, pans, utensils and a clothes washing machine. (*Apartments do not have clothes dryers, as these are not typically found in Italian apartments.*) Although apartments are of the same standard and have similar facilities, **no** two apartments are alike. They are not all located in the same building, but are all within walking distance to FUA or the nearest bus route.

Your accommodation includes:

- Repairs not caused by tenant negligence or carelessness.
- €50 (approx. US\$65) per month for utilities (water, gas, electricity) and a final cleaning fee. Students who leave their apartments dirty will be charged! *Excessive use of gas/electricity and/or required extra final cleaning will result in additional charges!*

Your accommodation does not include:

- Meals.
- Internet.
- Damages caused by tenant's or their guests' negligence or carelessness.

- It is understood that no refund of tuition, fees or rent will be given if a student is dismissed from the program. Such actions of misconduct include, but are not limited to, the following:
 - Excessive unauthorized absence from class and/or other organized program activities.
 - The use of threats or physical violence.
 - Violation of Italian laws.
 - Violation of the school or housing regulations.
 - Damage to or destruction of school, residence, or student property.
 - Alcohol or substance abuse.
 - Reckless or dangerous behaviour.
